Prerequisites:	The course is recommended for senior students, i.e. students in the third year of Bachelor Studies or MA students whose command of English enables them to read and analysemore complex academic texts and execute a research project.
Course content:	1. Selected issues of English academic writing - sentence and paragraph structure; - types of paragraphs; - coordinating and subordinating conjunctions; - punctuation rules; - rules for using and punctuating quotations. 2. A Diploma Thesis thesis structure; - stating the research problem, research question and hypotheses; - aim, scope and significance of the thesis study; - structuring the material and writing the thesis; - evaluation of an academic thesis. 3. Research methods and methodology types of research (descriptive vs. analytical, applied vs. fundamental, quantitative vs. qualitative, conceptual vs. empirical research) defining and formulating a research problem, conceptualizing research design, developing a theoretical and conceptual framework; - Literature review (primary and secondary sources, web as a source, searching the web; - developing of working hypotheses, types of hypotheses; - selecting a study design (qualitative and quantitative study designs/observational and interventional study designs); - data collection and analysis; - processing and displaying data; - establishing validity and reliability of research instruments; - ethical aspects of conducting research. 4. Writing and discussing an academic paper
